All Hoosiers ages 16 and older are eligible to receive the COVID-19 vaccine. Only the Pfizer vaccine is approved by the FDA for anyone

FEMA Clinic to open in Gary

Roosevelt Park, 730 W 25th Ave., Gary, IN 46407 April 7 – June 2 | 9 a.m. – 7 p.m. | 7 days a week

Indiana Governor Eric J. Holcomb, together with the Federal Emergency Management Agency (FEMA), announced Monday that an eight-week mass vaccination clinic with the capacity to administer 3,000 COVID-19 vaccines a day will open in Gary. The mobile clinic will run from April 7 to June 2 near the site of the former Roosevelt High School, a location recommended by Indiana and selected by FEMA based on its proximity to a large number of Indiana's high-risk citizens and medically-underserved populations. This clinic will have drive-through and walk-in access. Registration opens soon. You'll search by ZIP code 46407. You can also dial 211 (or 866-211-9966) for assistance.



To date, **1,162,464** Hoosiers have been fully vaccinated!

The <u>OurShot.IN.gov.</u> map now shows which type of vaccine the site is likely to offer and the vaccine registration page now offers translation into Spanish. Just click the button at the top right of the page when you begin the registration process to access the translated version.



Vaccine for higher education and businesses

The Indiana Department of Health is partnering with colleges and universities to launch campus COVID-19 vaccination clinics. The goal is to ensure college and university students are vaccinated before they return home for the summer. Watch for more specific information from your school.

We are also working with large employers in the state to set up onsite vaccination clinics. If you work at a large business with more than 1,000 employees, please check with your employer for more information.



The Indianapolis Motor Speedway (IMS) is hosting a vaccination clinic from 9 a.m. to 7 p.m. Appointments are still available the week of April 24. The IMS is located at 4790 W. 16th St. Indianapolis. This clinic is providing the single dose Johnson & Johnson (Janssen) vaccine approved for people ages 18 and older. Register at OurShot.IN.gov.





Here are the latest percentages of people who have scheduled or received a vaccine by age group. These percentages include nearly **152,000** first and second doses administered to residents and staff in long-term care facilities.

- 74% of Hoosiers 80+
- 77% of Hoosiers 70-79
- 66% of Hoosiers 60-69
- 48% of Hoosiers 50-59

- 35% of Hoosiers 40-49
- 25% of Hoosiers 30-49
- 10% of Hoosiers 20-29
- 107,769 Hoosiers 16-29 have scheduled a vaccination

"We have also heard great news coming from Pfizer that their clinical trials of 12- to 15-year-olds have found the vaccine to be 100% effective in preventing COVID-19 and was well tolerated in these populations. Pfizer reported that it expects to seek emergency use authorization from the FDA for these populations soon, so our hope is that we will have yet another age group that will be eligible to be vaccinated by this summer. In the meantime the most important thing that we can all do to protect our children who cannot yet get vaccinated is to get vaccinated ourselves."
